

Guidelines for Service Learning for the Alleghany Educational Foundation

Service learning activities are defined as those activities that provide a *benefit to the community*.

Activities that will typically count as service learning:

- Activities completed for a nonprofit organization
- Service activities as part of a school sponsored activity
- Any activity that is posted/announced by the Alleghany Educational Foundation (AEF) requesting volunteers
- Volunteer activities with youth sports organizations (coach, field personnel, etc) or school-sponsored sports (team manager, scorekeeper, videographer, etc)
- Church mission trips (only working hours), bible school, or mission activities

Activities that will typically **not** count as service learning:

- Any activities performed for family members
- Babysitting, unless there are extenuating circumstances (i.e.: providing respite for parents with a special needs child)
- Regular club activities – meetings, conferences, etc. (Club community service activities will count)
- Yard-work, unless there are extenuating circumstances (i.e.: providing services for an elderly or handicapped person)
- Sleep hours on overnight activities (mission trips, camp counselors, etc)
- Activities such as theater productions, concerts, etc.
- Hours completed as part of the Graduation project

If you have an activity that you feel is community service but you are unsure if it meets the above criteria, please see an AEF staff member to have it approved. It is recommended that you get approval prior to completing the activity to ensure it will count towards your hours.

All activities must be verified with a signature from the responsible person. Family members **may not** sign off on service learning activities.
